

# Klimabonus subsidies for the insulation of external walls

#### **Basic requirements**




Discover the list of craftsmen certified by Klima-Agence: klima-agence.lu/en/certified-craftsmen

Ask for a quote from a specialist company. Below you will find a summary of the requirements that your contractor must meet in its offer to ensure you are eligible for Klimabonus state subsidies.



### **Minimum insulation thickness: 15 cm** if its thermal conductivity is 0.035 W/(mK)

The minimum insulation thickness depends on the thermal conductivity of the material and may therefore vary as follows:



Requirements related to the choice of insulation material

#### Fossil-based insulation material

- The environmental index  $I_{ecol2}$  is less than 50 UI6/m² (except for the insulation of building elements in contact with the ground)
- Where a request for an "Agreement in Principle" was submitted since 01/01/2024, the fossil-based insulation must be made from at least 50% recycled materials.

#### Mineral insulation material

- It must be made of 100% mineral materials (including plaster)
- The environmental index  $I_{\rm eco12}$  is 23.7 UI6/m² at most
- The mineral insulation is **fixed mainly** in a removable way (with the exception of the plaster).

#### **Ecological insulation material**

- It must be made of 100% renewable materials
- The environmental index  $I_{ecol2}$  is 23.7 UI6/m<sup>2</sup> at most
- The ecological insulation is **fixed solely** in a removable way (with the exception of the plaster).

## Additional requirements



Discover the list of Klima-Agence certified advisors: klima-agence.lu/en/ certified-advisors Before the renovation work can be carried out, the Environmental Agency must give its "Agreement in principle"

- on the basis of energy-efficiency recommendations by a certified energy advisor, or
- for a single construction element, based on support from a certified energy advisor or an approved craftsman.

#### VAT rate of 3%

#### Additional bonus to Klimabonus subsidies

For renovation work, you are charged a greatly reduced VAT rate of 3% instead of the usual 17%, up to a total tax reduction amount of €50,000. The contractor carrying out the work applies the extremely reduced rate directly to construction or renovation work.

The residential building must be older than 10 years.
